

**RELEASE AND WAIVER OF LIABILITY,  
ASSUMPTION OF RISK, AND INDEMNITY CONSENT**

This Agreement is governed by the laws of the Province of Ontario and the laws of Canada applicable therein. IN CONSIDERATION of being permitted to participate in any way in the guitar repair workshops, instruction sessions, and related activities (collectively, the "Activity") conducted on the premises of Guelph Guitar Repair (located at 129 Woolwich Street, Guelph, Ontario), I, for myself, my personal representatives, assigns, heirs, and next of kin:

- ACKNOWLEDGE**, agree, and represent that I understand the nature of Guelph Guitar Repair's Activities, which may include but are not limited to: use of hand tools and power tools, soldering irons, electrical components, sharp instruments, adhesives, and chemical finishing products. I represent that I am sober, qualified, in good health, and in proper physical and mental condition to participate. I further agree that if at any time I believe conditions to be unsafe, I will immediately discontinue participation and notify staff.
- 2. FULLY UNDERSTAND THAT:** (a) THESE ACTIVITIES MAY INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING CUTS, BURNS, ELECTRIC SHOCK, EYE INJURY, HEARING DAMAGE, EXPOSURE TO CHEMICAL FUMES, PERMANENT DISABILITY, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable; and (d) I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.
- 3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE** Guelph Guitar Repair, its owner(s), operators, administrators, directors, agents, officers, members, volunteers, employees, other participants, any sponsors, advertisers, and owners and lessors of the premises on which the Activity takes place (each a "RELEASEE" and collectively the "RELEASEES") FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS. This release does not apply to liability arising from the gross negligence or willful misconduct of the Releasees.
- 4. AGREE TO INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES** from any litigation expenses, legal fees, loss, liability, damage, or cost which they may incur should I, or anyone on my behalf, make a claim against any of the Releasees, NOTWITHSTANDING THAT SUCH CLAIM MAY HAVE BEEN CONTRIBUTED TO OR OCCASIONED BY THE NEGLIGENCE OF ANY OF THE RELEASEES.
- 5. CONSENT TO PHOTOGRAPHY AND MEDIA:** I grant Guelph Guitar Repair permission to photograph or video record me during the Activity for use in promotional and educational materials. I may withdraw this consent in writing at any time. (Circle one: I CONSENT / I DO NOT CONSENT)
- 6. HEALTH DECLARATION:** I confirm that I am not aware of any physical or medical condition that would prevent my safe participation in the Activity. I understand it is my responsibility to inform Guelph Guitar Repair of any relevant health conditions or limitations prior to participation.
- I HAVE READ THIS AGREEMENT IN ITS ENTIRETY, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE. I INTEND THIS TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW UNDER THE PROVINCE OF ONTARIO. IF ANY PORTION OF THIS AGREEMENT IS HELD INVALID, THE REMAINDER SHALL CONTINUE IN FULL FORCE AND EFFECT.**
